To nominate, you must:

- currently completing year 10, 11 or 12,
- studying VETiS in tourism or hospitality at school in Queensland, studying a SIT training package qualification, or
- a school-based trainee or apprentice in Queensland studying a SIT training package qualification.

Students must complete the nomination as outlined below:

- 2. Name the relevant qualification that you are completing or have completed
- 3. Outline if you are School Based Trainee or VETiS
- 4. Include teachers email for endorsement
- 5. Respond to Selection Criteria Personal qualities
- 6. Respond to Selection Criteria Knowledge and Skills
- 7. Respond to Selection Criteria Industry Focus
- 8. Upload resume
- 9. Upload supporting information
- 10. The selection criteria response must be no longer than 500 words each. Responses exceeding this limit will not be able to be submitted.
- 11. Any digital media or uploads provided to support your application must not exceed 2MB. Supporting information may include.
 - Samples of industry related project work you have completed
 - Photos detailing industry related work you have completed or participated in
 - References and/or testimonials from hospitality or tourism industry workplaces
- 12. Documents that can be uploaded include .JPG, .jpeg, .png, .pdf, .doc. Each file cannot exceed 50mb.
- **13.** Student must upload completed signed copies of the consent form that is in Appendix 2 Consent Form of this document. (**Please note nominees under the age of 18 will require a parent's signature**)
- 14. Nominees are required to upload a copy of their recent resume.
- 15. Nominees will receive an automated notification of receipt of their completed submission via email.
- 16. Nominees will require either a teacher or trainer to endorse the nomination. Students will be required to enter their teachers or trainers' email and contact number for this purpose.
- **17.** Students should complete and save all answers on a word document prior to completing the online application. Students will then be able to simply copy and paste responses into the correct field in the online portal.
- **18.** Online Submissions **cannot exceed** the **500** -word limit and **2000** -character limit for each response.

SELECTION CRITERIA

CRITERION 1 - PERSONAL QUALITIES — WEIGHT 50%

- Comment on actions that provide evidence of your abilities and attitudes in relation to:
 - o motivation & commitment
 - o teamwork
 - o work ethic
 - o time management
 - safety
 - o initiative

CRITERION 2 - KNOWLEDGE & SKILLS - WEIGHT 20%

Consider:

- How have you developed and applied both theory, and practical skills gained during your course?
- Comment on your most significant training or industry related achievements during your course.

Online Submission:

- 500-word limit
- 2000-character limit

CRITERION 3 - INDUSTRY FOCUS - WEIGHT 30%

Consider:

- How has you been training in school and vocational experience helped to develop your interest in the industry?
- How has your training enhanced your career and study opportunities?
- What are your future and career aspirations within the industry?

Online Submission:

- 500-word limit
- 2000-character limit

TOTAL WEIGHT - 100%

• Nominees must receive a total score of 50% or above to be an eligible finalist.

JUDGING PROCESS

1ST ROUND JUDGING

QTIC will receive all applications and once nominations have closed, judges will be provided access to their category online. The judges will then review the nominations for their category and place a score against each category. The Judging Panel consists of six judges, two per category, from industry. The panel will shortlist finalists for each category based on completed submissions.

2ND ROUND JUDGING

Shortlisted finalists will be invited to participate in 2nd round of judging that will consist of:

- · A virtual interview through an online platform,
- theory test submitted electronically through Judgify
- practical evaluation through a series of self-recorded videos submitted through Judgify

The online interview will be conducted by two judges in the relevant category on Monday the 27 June 2022. A QTIC team member will contact the finalists to schedule the interview.

Category winners will be announced at the Salute to Excellence Awards Dinner event being held on Monday 25 July 2022. Further information will be provided to finalists.
