As a judge, you will play a critical role in evaluating the achievements of tourism businesses across multiple categories, upholding the credibility of the awards, and contributing to the recognition of industry excellence. Your involvement is vital in ensuring that the awards continue to highlight the businesses and individuals driving Queensland's tourism success.

#### Key responsibilities

As a judge, you will be responsible for:

- Reviewing nominations and submissions across various award categories.
- Participating in judging panels, either in-person or virtually.
- Evaluating applications based on criteria including innovation, sustainability, business performance, and community impact.
- Maintaining confidentiality and impartiality throughout the judging process.
- Providing constructive feedback via the submission portal to entrants where appropriate.

#### Essential criteria

To be considered for a judging role, applicants must meet the following criteria:

- At least 5 years of professional experience within the Queensland tourism industry, with a strong understanding of regional tourism, industry trends, and best practices.
- Demonstrated understanding of business operations within the tourism sector, including accommodation, food and beverage, attractions, and tour operators.
- Previous involvement in awards judging or experience in a senior leadership or advisory role within the tourism sector is highly desirable but not imperative.
- A demonstrated ability to assess nominations objectively, free from personal bias or conflict of interest.
- Strong verbal and written communication abilities for providing clear and constructive feedback to entrants and fellow judges.

#### Desirable criteria

- **Leadership in Tourism**: Significant contributions to the growth, development, or promotion of Queensland tourism at a regional or state level.
- **Experience in Niche Tourism Areas**: Specific experience in sectors such as eco-tourism, luxury travel, Indigenous tourism, or regional tourism is considered an asset.

1. A current resume detailing your professional experience in the tourism industry.



- 2. A brief cover letter (max. 500 words) outlining why you wish to become a judge and how your experience qualifies you for this role.
- 3. Any previous experience in judging or assessing award submissions, if applicable.
- 4. Two professional references from the tourism industry.

EOI submission deadline: 1 April 2025

#### **Selection Process:**

All applications will be reviewed by QTIC and the Awards Chair of Judging. Shortlisted applicants may be invited for an interview or discussion to assess their suitability for the role. Selected judges will be notified asap.
