Working Towards a More Inclusive Industry

Following successful trials in Tasmania and Western Australia, next month QTIC will launch an accessibility selfassessment module for the Queensland tourism industry. Developed by the Australian Tourism Industry Council (ATIC) in consultation with TravAbility, the ATIC Accessibility self-assessment module aims to help businesses evaluate how inclusive their experience offering is for people living with disability.

The module will be made available via the Quality Tourism Framework online dashboard and aims to increase visibility for accessible experiences and encourage more tourism businesses to make adjustments that will accommodate more visitors of all abilities. There will be a range of accessibility modules available, including:

- · Limited mobility
- Wheelchairs and scooters
- Low vision
- Low hearing
- Cognitive/autism
- Allergies or intolerances


First Nations Update
