# **Queensland Restrictions Update**

New restrictions will come into place from 1am Tuesday, 29 June for the 11 local government areas of Brisbane, Ipswich, Logan City, Moreton Bay, Redlands, Sunshine Coast, Noosa, Somerset, Lockyer Valley, Scenic Rim and Gold Coast.

- Face masks must be worn at all times whenever you leave your home, unless you have a lawful reason not to. Masks must be worn in indoor spaces such as shopping centres, public transport, hospitals, aged care facilities, churches and workplaces where you can't physically distance.
- You must be seated to drink or eat in cafés and restaurants, and businesses and venues must return to the one person per 4m<sup>2</sup> inside and one person per 2m<sup>2</sup> outdoors, while smaller venues up to 200m<sup>2</sup> are allowed one person per 2m<sup>2</sup> with a maximum of 50 people.
- Private gatherings are restricted to 30 people, and up to 100 people can attend weddings and funerals. Only 20 people can dance at weddings.

The First Nations Tourism Working Group have been travelling across the state consulting with key groups to inform the establishment of the First Nations Tourism Peak Body for Queensland. The survey is still open so have your say before 30 June 2020. All responses will be factored into the development of the draft model to be presented at our NAIDOC Corporate Breakfast.

# **Research and Policy Update**

- **Great Barrier Reef:** With the first public hearing for the Environment and Other Legislation (Reversal of Great Barrier Reef Protection Measures) Amendment Bill 2021 officially concluded, QTIC has begun preparing a submission, accounting for the limited voluntary uptake of regulatory measures, the harmful perception of a 'dead reef' on the tourism industry, and the need for peer education and collaborative stewardship.
- **Reimagining the visitor economy:** QTIC has made a formal submission in relation to the 'Reimagining the visitor economy' discussion paper released by the Australian Trade and Investment Commission. QTIC largely echoed the Australian Tourism Industry Council response, which advocated for industry-led, government enabled reform. The submission viewable here also serves as an aggregate of many key pre-existing QTIC strategies, promoting the national adoption of several programs and plans.
- Insurance for the tourism industry: QTIC contributed the now-finalised and released Insurance Project report to the Treasury consultation paper for a 'Reinsurance pool for cyclones and related flood damage'.
- 2021-2022 State Budget: In response to the Queensland State Budget, QTIC has put together
  a summary of highlights and areas of concern for the tourism industry. As you can see here, the
  budget included some big wins for the workforce!

# FCB Article: Annual Wage Review 2021

On 16 June 2021, the Fair Work Commission's (FWC) Minimum Wage Panel handed down its longanticipated decision on the annual wage review, setting the minimum wages for the next financial year.

After months of considering evidence and submissions from stakeholders, including employer groups, unions and the Government, the FWC has made its determination for the minimum wage across the 2021-2022 financial year. The decision ensured an increase of 2.5% to the National Minimum Wage, effective from the first full pay period after 1 July 2021, which takes it up to \$772.60 per week or \$20.33 per hour. The Tourism Industry Reference Panel has now released a discussion paper to start the conversation and understand how Queensland can design the future of the state's multi-billion-dollar tourism sector.

Your input is needed on the opportunities you see and the barriers we will need to overcome to position Queensland for success after COVID-19. Feedback will help to identify the actions government and industry will take through a new Action Plan for Tourism Recovery.

The discussion paper describes Queensland's tourism past, highlights the changes the Panel is seeing and asks industry to share their ideas for the future. To have your say, visit get involved to complete a short survey or provide a written submission.

#### Consultation closes Monday 28 June 2021.

The Panel was established by the Queensland Government in March 2021 to oversee development of a new Action Plan for Tourism Recovery. This is about taking a step back and looking long-term at the actions industry and government will need to take to be successful in the future.

The Panel will carefully consider all feedback and responses to the discussion paper to deliver an interim action plan in the second half of 2021 and oversee further work to deliver a final action plan by early 2022.

The ban is part of Queensland's plan to tackle plastic pollution and follows strong support from the community, retailers and industry organisations.

QTIC was happy to participate in the consultation of this plan. The banning of single-use plastic fits into our overall agenda and priorities for a sustainable future for tourism.
